Health Meeting

Maricopa County Environmental Services Department staff reviewed twenty-four (24) new fee waiver applications that are being presented to the Board of Health as an agenda item for approval/denial at the April 27, 2020 meeting. In addition two (2) applications carried over from the January 27, 2020 Board of Health meeting are being presented again. Said fee waiver applications are listed on the attached April 27, 2020 Fee Waiver Application Summary Sheet and the attached Deferred Fee Waiver Application Summary Sheet.

Based on information provided during the current application process, all listed permitted operations on the April 27, 2020 Fee Waiver Application Summary Sheet appear to meet criteria set forth in the Maricopa County Environmental Health Code Chapter 1, Regulation 5. At the Board's direction, staff reached out to the two deferred applicants Laveen Education Foundation and Heritage Square Foundation, to provide them with an opportunity to provide additional information on the reasons they may qualify for a fee waiver. The applications were orginially recommended for denial based on the following reasons:

1. Laveen Education Foundation does not operate to provide relief solely to the poor distressed or under-privileged. When asked ". . .are 100% of the scholarships awarded to students who are poor, distressed or under-privileged?" they replied "I cannot quantify that 100% of scholarship recipients are poor, distressed or under-privileged. While it is a heavily-weighted factor in the determination, it is possible that other aspects of the student's grant application could out-score their financial need."

When contacted for additional information on April 8, 2020 the applicant indicated "Those two questions (regarding financial need) are assigned up to 10 points, whereas the other questions are assigned at 5 points. So yes, those questions are more heavily weighted than the other questions."

A representative from the Laveen Education Foundation has indicated they intend to address the Board of Health at the April 27, 2020.

2. Heritage Square Foundation, dba The Bungalow at Heritage Square, does not operate to provide relief solely to the poor, distressed or under-privileged. When asked if they provide services solely to the poor, distressed or under-privileged they replied "We do not have any specific program for that demographic".

When contacted for additional information on February 27, 2020 the applicant stated ". . .talked to another individual from your group & clarified that we do not met the requirements asked for".

A representative from the Heritage Square Foundation had indicated they do not wish to pursure a fee waiver so this application has been withdrawn from consideration by the Board.
